## **INTRACO Prime Obtains a Use Permit**

**PHN has obtained the permit to use the INTRACO Prime office and retail building in the Warsaw district of Muranów at ul. Stawki 2B. The project has been completed on schedule.**

INTRACO Prime is a state-of-the-art A-class office building with an area of ca. 13,000 sq m with retail spaces on the ground floor. Aside from its excellent location, the building offers a broad range of advantages, such as energy-efficient systems and installations, parking spaces and changing rooms for cyclists, as well as electric car charging stations. The project has been executed in conformity with BREEAM certification requirements.

*“INTRACO Prime is yet another project we executed during the pandemic. Despite the turmoil on the construction market, works were completed smoothly and on schedule, and we obtained a use permit for the building.
